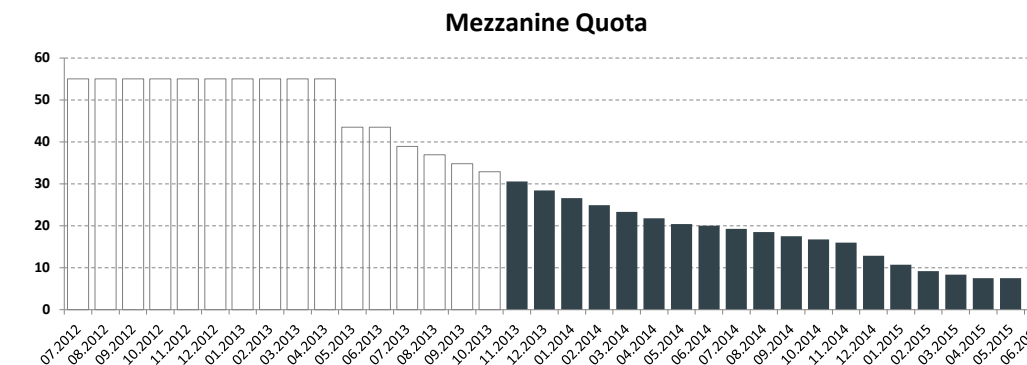
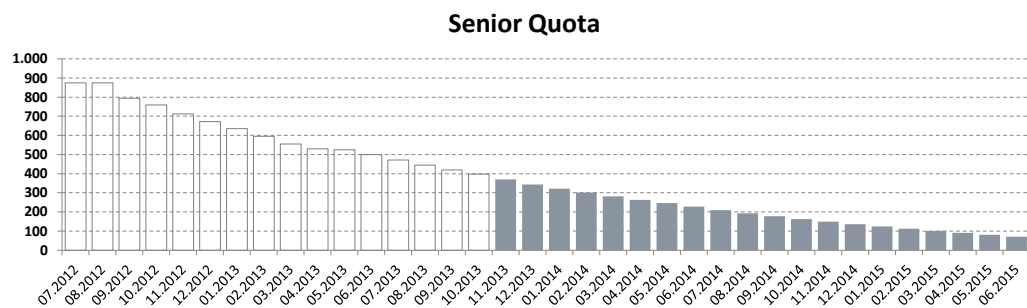

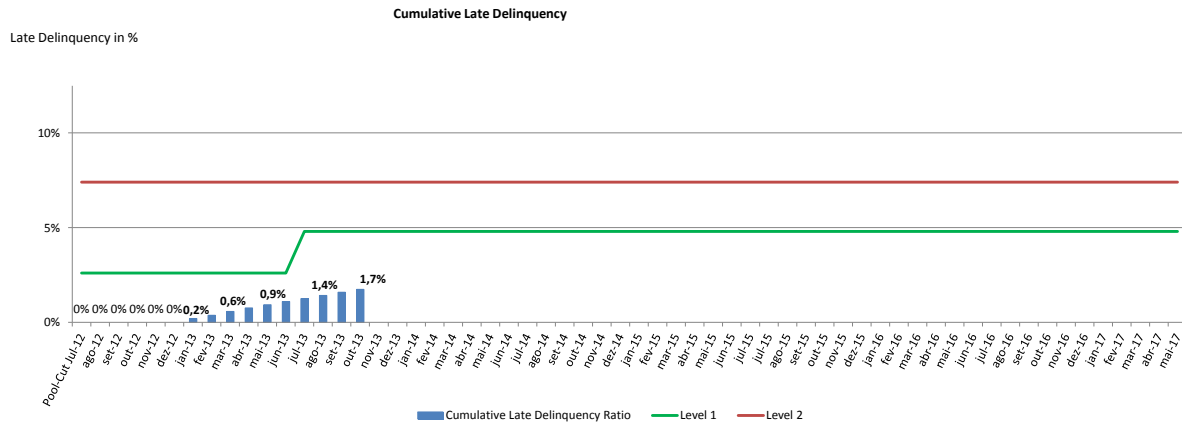

Performance Pool vis-a-vis Triggers

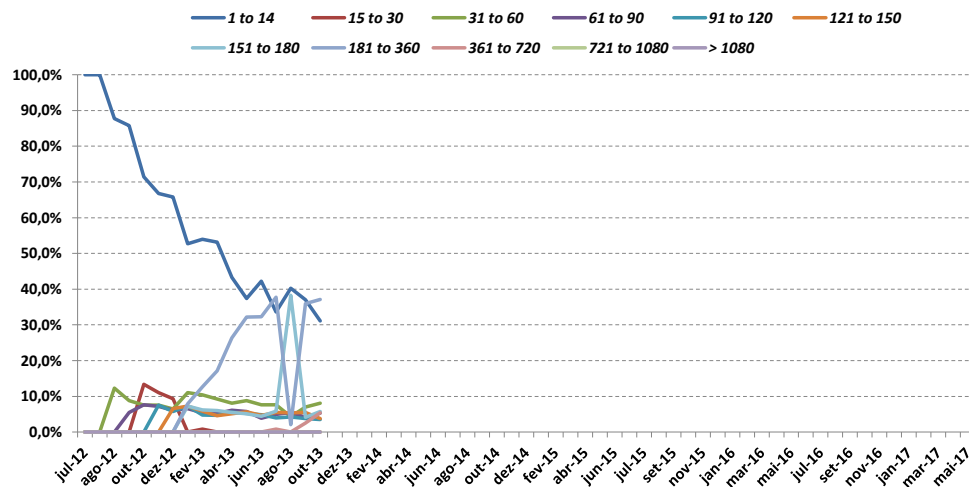

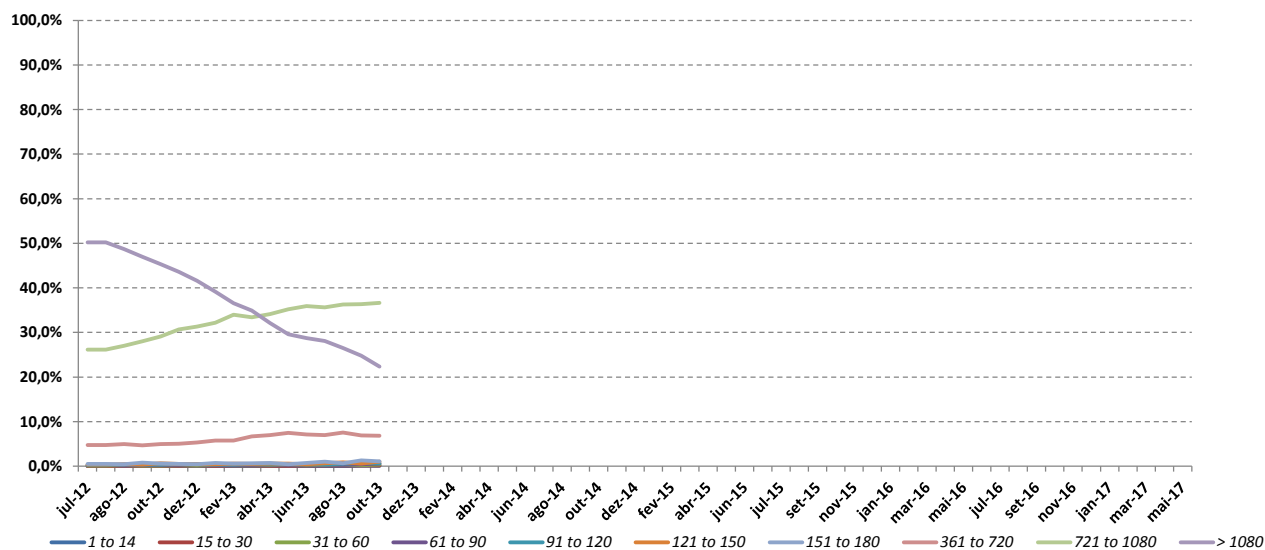
Delinquency Performance - Historical Data (by bucket)

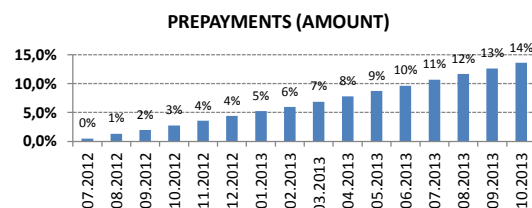
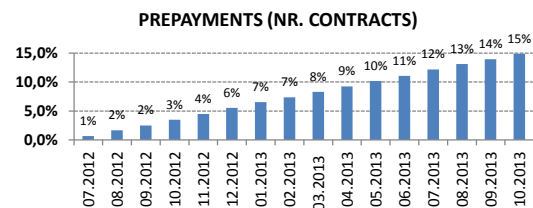

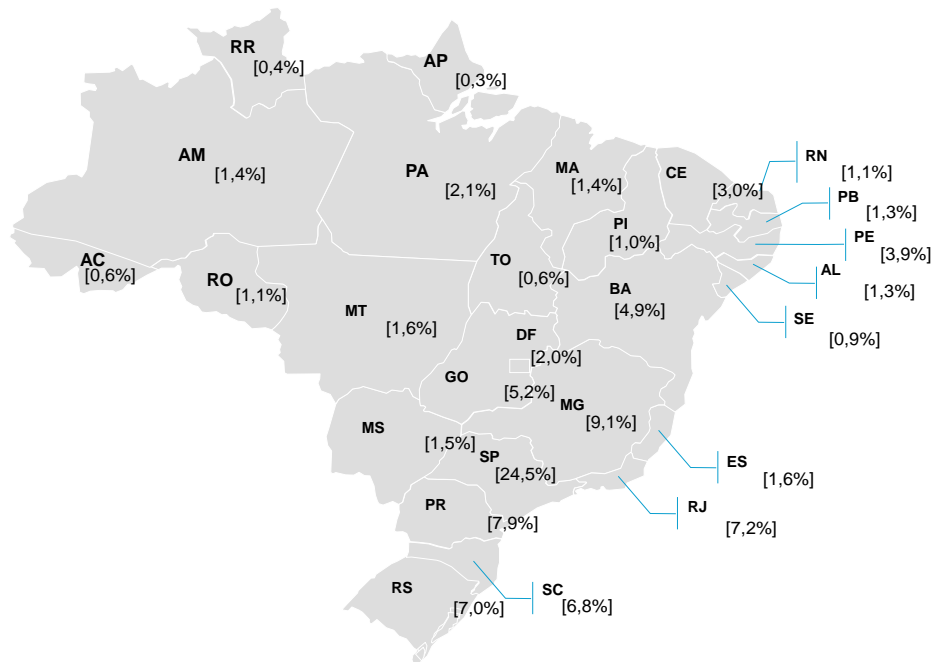
