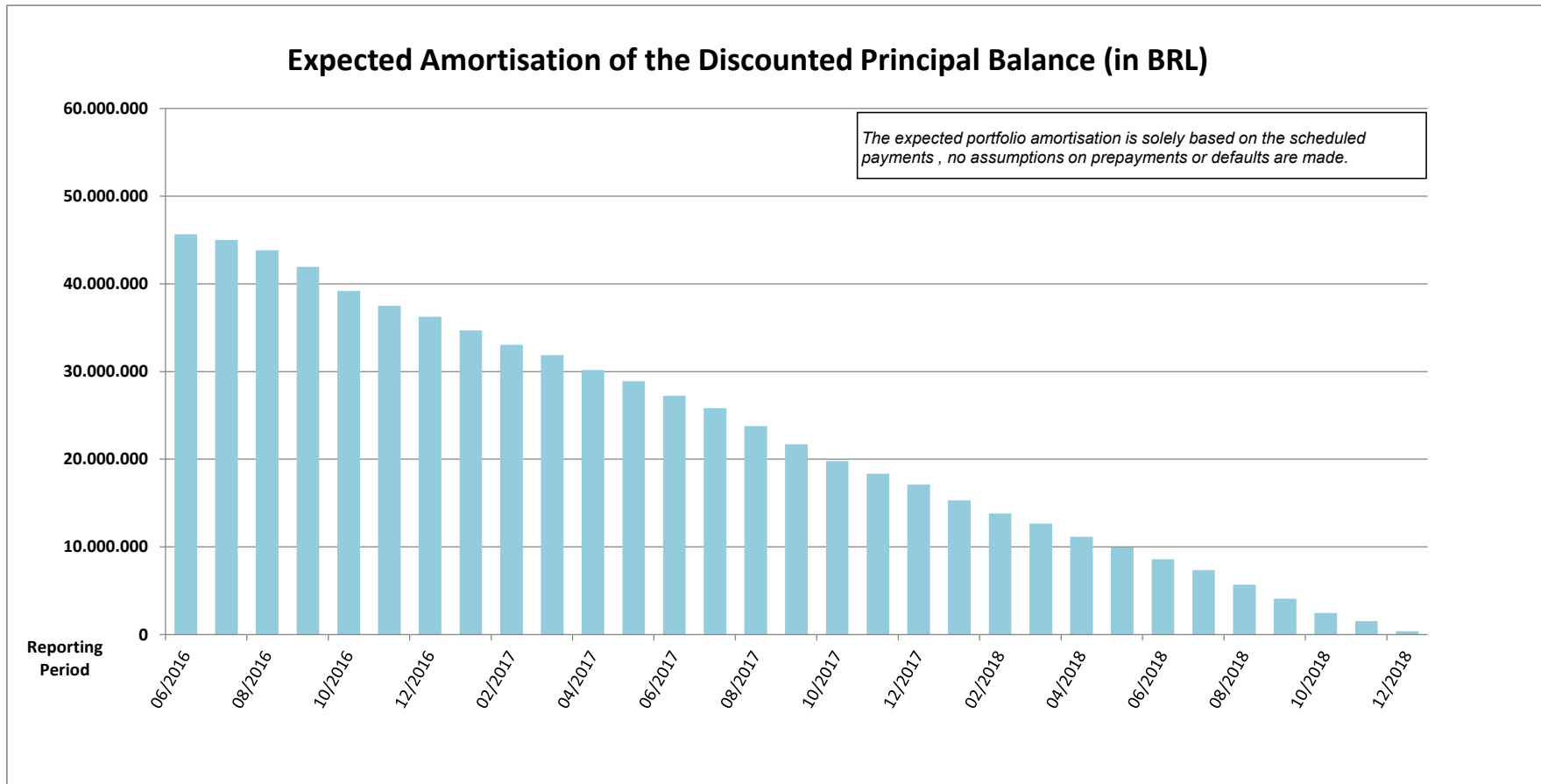
Amortisation Profile II

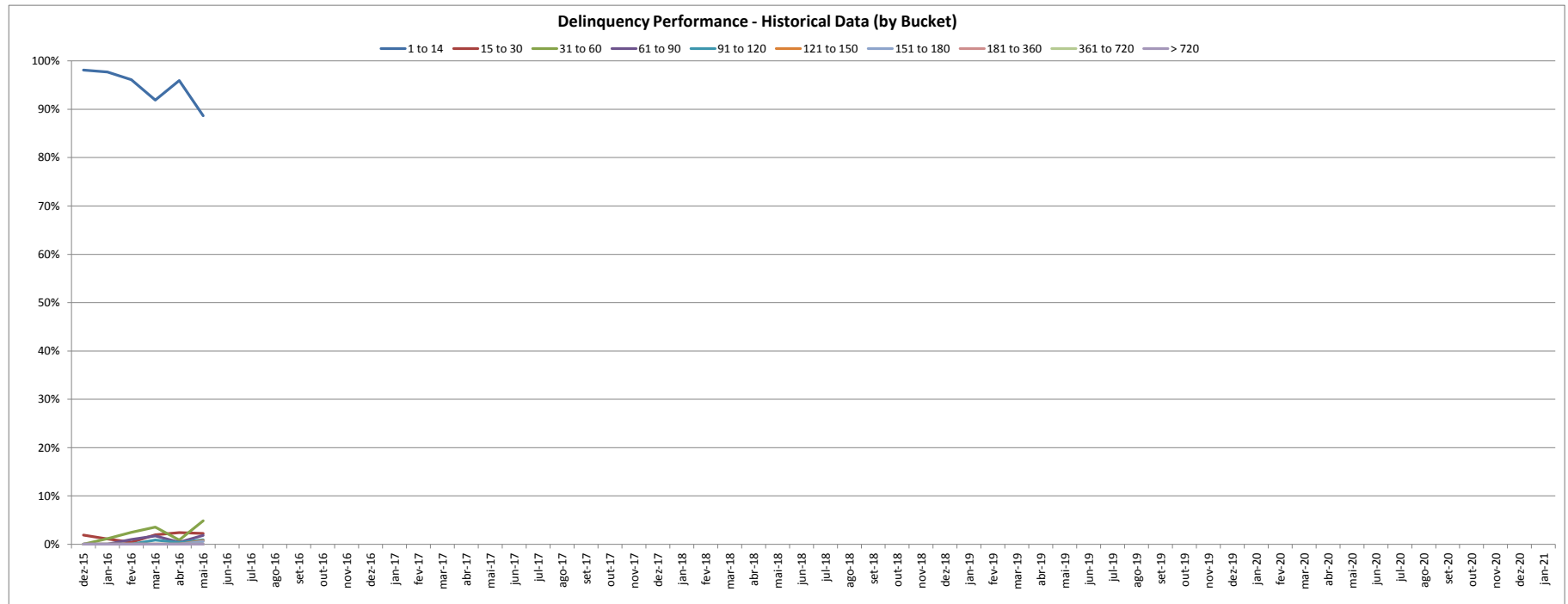
